 Applicable to Credit Customers

These terms and Conditions shall apply to Purchaser to which Ki Mobility LLC consents to extend credit. Completion of this application conveys to Purchaser no right to credit, which is solely at Seller's discretion. Seller's consent to extend credit to Purchaser is made in reliance upon the representations of Purchaser in the application and in reliance upon any and all information furnished to Seller by Purchaser either directly or indirectly. Purchaser acknowledges and agrees that the following Terms and Conditions apply to all credit sales, and in addition that Seller's general terms and conditions apply to all credit sales and non-credit sales, of product by Seller to Purchaser.

Limited Warranty. Seller warrants that, for the warranty periods defined in the user manual for the specific model purchased, this product was manufactured to the Sellers specifications. Specifications are available upon request. This warranty does not cover or include any modifications made to the product after initial shipment to Purchaser. THE FOREGOING WARRANTY IS IN PLACE OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED. SELLER EXPRESSLY DISCLAIMS ANY OTHER WARRANTIES INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. ALTHOUGH SELLER MAY HAVE SUGGESTED THE PRODUCT OR DEVELOPED THE PRODUCT, IT IS THE SOLE RESPONSIBILITY OF THE PURCHASER TO INSURE THE SUITABILITY OF THE PRODUCT FOR THE PURCHASERS INTENDED USE AND PURPOSE. PURCHASER ASSUMES ALL RISK AND LIABILITY WHATSOEVER REGARDING SUCH SUITABILITY, FOR ANY VALID CLAIM PRESENTED UNDER THE WARRANTY, SELLER WILL REPLACE THE PRODUCT, OR AT ITS OPTION, REFUND THE PURCHASE PRICE. THIS REPLACEMENT/REFUND REMEDY IS THE PURCHASERS SOLE AND EXCLUSIVE REMEDY AGAINST THE SELLER. THE PURCHASER AGREES THAT NO OTHER REMEDY (INCLUDING, BUT NOT LIMITED TO LOST PROFITS, LOST SALES, INJURY TO PERSON OR PROPERTY OR ANY OTHER INCIDENTAL OR CONSEQUENTIAL LOSS) SHALL BE AVAILABLE TO THE PURCHASER FOR CLAIMS ARISING OUT OF ANY USE OF THE PRODUCT REGARDLESS OF THE LEGAL THEORY (CONTRACT, TORT OR OTHER). IN NO EVENT WILL SELLER BE OBLIGATED TO PAY DAMAGES TO PURCHASER FOR ANY AMOUNT EXCEEDING THE PRICE THAT PURCHASER PAID FOR THE PRODUCT.

Delivery. Deliveries shall be F.O.B. Purchasers business address. Drop shipments shall accrue additional charges. In the case of damage during shipment, Purchaser is required to file all reasonable claims with the transportation company within their designated timely fashion. Seller's liability is limited to replacing the actual item damaged or the entire package, at the Seller's sole discretion. Purchaser shall return all damaged items to Seller at Seller's discretion.

Terms of Payment and Price. Subject to approval and continuation of credit by Seller, the terms and payment are net 30 days except as specifically stated in the invoice. Seller

hereby notifies Purchaser that Seller has lien rights to the products that Seller ships to Purchaser and that Seller may reclaim such products should Seller's invoices not be paid according to the payment terms, which have been mutually agreed upon.

Legal fees. Purchaser will be liable and reimburse Seller for any and all actual collection agency and attorney fees and costs incurred by Seller to enforce the terms and conditions stated herein.

Entire Agreement. This agreement constitutes the entire agreement between the Parties and supercedes all prior agreements and understandings whether written, oral or implied between the parties with respect to the subject matter hereto.

Credit Information. Applicant authorizes Ki Mobility LLC to obtain from applicant or third parties such information as Ki Mobility may require in connection with Application for Credit. Applicant certifies that the information contained in the Application for Credit and all financial information is true and correct and acknowledges that Ki Mobility will rely on such for extending credit.
